#### Prevention:

- 1) Minimise contact with individuals who are required to self-isolate by ensuring they do not attend school.
- 2) Advise to clean hands thoroughly more often than usual
- 3) Ensure good respiratory hygiene by promoting the 'catch it, bin it, kill it' approach
- 4) Continue enhanced cleaning, including cleaning frequently touched surfaces using standard approved products such as detergents and proven sanitisers.
- 5) Keep occupied spaces well ventilated

### Response to any infection:

- 9) Engage with the NHS Test and Trace process as appropriate
- 10) Adopt Outbreak Management Measures if advised
- 11) Following local health protection team advice
